






Responsibilities: Taking Classes on HR and General Management, Students counselling, General Administration including students and staff welfare and Office work as and when given to you by the management.



Notice Period: If you want to leave the institution, you need to give a notice mentioning the reason for your leaving before 30 days of leaving our institution.


